NOTICE IS HEREBY GIVEN that the City Council of the City of Montebello will hold a Public Hearing in the Council Chamber of the Montebello City Hall, 1600 West Beverly Boulevard, Montebello, California and via telephonically and/or electronically, on **Wednesday, July 28, 2021, at 6:30 p.m.**, or as soon as possible thereafter as the matter can be heard, to consider the following:


Levying the proposed assessments for the City's Natasha Lane Landscaping Assessment District 2005-1 for Fiscal Year 2021-22:

Natasha Lane is a twenty-unit housing development, extending to the south from Whittier Boulevard and to the east of Bluff Road. As part of the development, new landscaping was installed within a storm drain easement at the southerly terminus, along frontage of the property facing Whittier Boulevard and at the end of the cul-de-sac. The City is responsible for the maintenance of landscaping in these areas. The special assessment district was initially established in 2005 when the development was constructed. This special assessment is added to the Los Angeles County Tax Roll annually. On June 23, 2021, the City Council approved Resolution No. 21-51 initiating proceedings for the FY 2021-2022 levy of annual special assessment and residents were notified on July 12, 2021.

All interested persons have the right to appear and be heard pursuant to Governor Newsom's Executive Orders N-25-20 and N-29-20. For those interested in making public comments, the City will receive your comments by contacting the City Clerk's office **on or before Wednesday, July 28, 2021 between 9:00 a.m. – 3:30 p.m. at (323) 887-1359**. Staff will complete the speaker cards and the public will be called during the City Council meeting – Closed Session begins at 5:30 p.m. and Regular Session begins at 6:30 p.m. The exact call back time is not predictable due to the nature of the City Council agenda. As a result, you must be available until the end of the meeting to receive a live call from staff during the meeting. The City has created an email address ccpubliccomment@cityofmontebello.com where the public can submit public comments from **9:00 a.m. – 3:30 p.m. on Wednesday, July 28, 2021**. These questions will be read out loud and submitted for the record. If you challenge the subject matter in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City Council, at, or prior to, the public hearing.
